## 1<sup>st</sup> Klas Marina Rental Boat Policy

### Eligible Renters

- Renters and drivers must be at least **21 years of age**.
- Renters and drivers must have a valid driver's license and credit card.
- The person who signs the rental contract is defined as the driver and therefore will be the only individual allowed to operate the boat during the contracted time period.
- Operators must have some prior boating experience.

### How Renting a Boat Works

- Renters may call or walk-in to reserve a boat. If you walk-in, we cannot guarantee there will be a boat available to rent.
- To reserve your rental, a \$250 deposit is taken at the time of the reservation. If you are reserving the boat for more than 1 day, an additional \$50 deposit will be required for each additional day of rental.
- Only a credit card will be accepted for the security deposit, **NOT** a debit card.
- The card must be present on the day of rental. Balance can be cash, check or credit card.
- A \$500 security deposit is authorized to your credit card the day of the rental. If there
- Are no damages incurred during your rental, the deposit will be released.
- Rental rates **DO NOT** include tax, fuel or gratuity.
- \*\*\*\*\***NO refunds for unused time**\*\*\*\*\*

### Rental Times

- REGULAR SEASON (May 15<sup>th</sup>-September 15<sup>th</sup>) Extended season may be available, please call for info.

### Rental Rates

- Our rates are structured according to the day of the week and the time of the season.
- Please call for current rates.
- Navigational maps will be provided. Renters may only take the boat as far as Ledgedale Marina. Unseen underwater structures could damage the boat and/or motor.
- The renter will be liable for any and all damages incurred during the rental period.
- Gas policy: The boat will be provided with a full tank of gas. Upon the completion of your Rental period, gas dock attendants will be available to assist in docking and refueling Procedures. The boat must be refilled with gas or the renter will be charged a \$30 fee plus the cost of all fuel, or a prepayment of \$150 may be made in advance to cover the Fee and fuel Costs.
- Rental includes:
  - Coast Guard approved life jackets, Throwable cushion, Dock line, Map, Anchor kit and Fire extinguisher.
  - A Boating Safety Education Certificate is required for anyone born after January 1, 1982. You may be required to watch a short Boater Safety video and complete an evaluation of skills in order to qualify for a temporary Boating Safety Certificate [www.boat-ed.com/pennsylvania/](http://www.boat-ed.com/pennsylvania/)
- All children under 13 **MUST** wear USCG approved life jackets while the boat is moving.

It is recommended that personal lifejackets are brought for any small children or infants.

- No pets will be allowed on rental boats.
- No grilling allowed on boats.
- Please abide by all marina rules if docking the boat at 1<sup>st</sup> Klas.
- If keeping the boat elsewhere, provide exact location, address and Brookfield dock number of where the boat will be located.

### Late Arrival or Return Policy

- If you are late to pick up your reserved rental, you will forfeit any time lost on the water.
- The boat will still be required to be returned by your originally scheduled time.
- If returned 15-30 minutes late, a \$90 fee will be charged.
- If more than 30 minutes late, you will be charged double the hourly rate.
- Renters must allow for 30 minutes at the beginning and end of the rental period for Orientation, refueling and disembarking.

### Cleaning Charge

- If the rental is returned in a manner which will require extra attention to provide the same clean experience for the next customer, a fee of \$75 will be assessed. Examples include but are not limited to, sand, food, trash, spills, etc.

### Alcohol Policy

- Operator of the rental is not allowed to consume **ANY** alcohol while in possession of the rental.
- No kegs will be allowed on board.
- No drunk or disorderly conduct will be tolerated.

### Cancellation Policy

\*\*\*\*The full reservation deposit will **ONLY** be refundable if cancellations are made at least 96 hours (4 day) prior to your reservation date less a \$25 cancellation fee. **ONLY** due to hazardous weather conditions on the date of the reservation will your deposit be refunded minus a 5% transaction fee. No shows are charged in **FULL**. Hazardous weather conditions include lightning, tornado warnings ,high wind advisories and conditions at our discretion.

### Purchase Policy

\*\*\*\*Any previous rental customer who purchases a new boat from 1<sup>st</sup> Klas Marina within a period of 30 days from the initial time of rental, will receive a credit for 50% of the rental cost to be applied toward the overall cost of the new boat purchased. Rental boats will be listed for sale towards the end of the season, as we continue to rotate boats through our rental fleet. These boats will be available at a great value!!
